- Hat collection: Expressly encouraged – all proceeds belong to the artist.
- Performance duration: 20–30 minutes per set, on the hour.
- Setup/Teardown: 20–30 minutes before the performance. Teardown immediately after.
- Stage: Buskers Corner in the festival tent (covered). Basic sound system available.
- Parking: Limited spaces available at the municipal car park. Allocation by organiser.
- Registration deadline: 15 January 2027 by post or e-mail to info@gin-garage.ch.
- Selection: Selection is made by the organiser based on variety and programme mix. Feedback by end of January/mid-February 2027.

6. INSURANCE & LIABILITY

Insurance is the responsibility of the busker (liability insurance recommended). The organiser assumes no duty of care over infrastructure, instruments, and equipment. Subject to Art. 100, Para. 1 of the Swiss Code of Obligations (OR), the organiser excludes all liability for damage and loss.

7. CANCELLATION / FORCE MAJEURE

In the event of cancellation of the festival due to force majeure (severe weather, official orders, etc.), there is no entitlement to compensation. The organiser will inform as early as possible.
